### **“Realizing the Vision of the Smart Home”** Special 30 Minutes Presentation

Description: In the B2B space, the IoT market is well advanced. The majority of new commercial buildings are ‘smart’; systems are integrated to make them safer, more energy efficient, easier to manage, and the cost of operation is significantly reduced. However, the B2C channels are lagging

when it comes to exploiting the IoT.
