1. Agenda - Greg Walker (CABA)

US Services, Inc.). Roy Perry (Alarm.com) also outlined the role of the CHC.

3. Administrative - Roy Perry (Alarm.com)

3.1 Motion to approve Past CHC Minutes

3.2 Motion to approve Byron BeMiller (Semtech Corporation) and Charles Hume (Southwire Company, LLC) as new CHC Vice-Chairs

Motion to approve Byron BeMiller (Semtech Corporation) and Charles Hume (Southwire Company, LLC) as new CHC Vice-Chairs was moved by Maurice Okawaki (Frost & Sullivan) and the motion was seconded by David Katz (Sustainable Resources Management Inc.). Unopposed motion carried.

3.3 Discussion and Motion to approve CHC Changes

The following changes were proposed by Roy Perry (Alarm.com):

- 1) Name change from "Connected Home Council (CHC)" to "Connected Home Consortium (CHC)"?
- 2) CHC Executive Committee (Chair and Vice-Chairs) should meet guarterly with formal minutes and Roberts Rules of Order, etc.
- 3) New CHC Webinars should be held quarterly (30min 1hr).
- 4) New CHC Advisory Committee.
 - Made up of approximately 10 individuals
 - The CHC Executive Committee would select the members to serve on the CHC Advisory Committee

- Would meet quarterly to select topics and arrange for speakers quarterly CHC Webinars
- CHC Committee will be organized and led by the CHC Chair and not CABA Staff
- 5) New CHC Meeting format would no longer have keynote speakers (30min 1hr)

There was strong objection from Ken Kacks (Ken Wacks Associates), David Katz (Sustainable Resources Management Inc.) and other CHC members to items #1, #3 and #5. The CHC objected to a name change, additional webinars, and the elimination of the keynote speaker or panels from the current CHC meetings.

It was decided by Roy Perry (Alarm.com) and the CHC would not implement these changes, but to put them on hold. The CHC Executive Committee would be discussing the proposals and feedback at a future meeting.

CHC White Papers are secondary literature review articles that are approximately 10-20 pages in length. These papers are written and distributed free of charge to inform the industry. For the papers to be approved by the CHC White Paper Sub-Committee (WPSC), they must have significant technical material of relevance to CHC members - they must not contain marketing material or promote an agenda. Any CABA member can and is encouraged complete the new one (1) page white paper proposal template and submit it to walker@caba.org.

If needed, CABA will secure a writer and/or a Working Group for the paper. If a CABA Member brings forward a proposal but is not able to find an author for the paper, the Member will need to send CABA \$500 USD. CABA will attempt to locate an author from one of many research firms. The \$500 will be given to the author(s) as an honorarium for their work in writing the paper. If an author cannot be found, the \$500 will be returned to the Member.
