

Terms of Reference - Updated May 2021

- The CABA Information Council (CIC) works to further the association's mission, which is to foster "informed thought leadership and collaboration within intelligent built environments to deliver a more livable, sustainable and efficient connected world."
- 2. The CIC has a mandate to review industry research reports, case studies, white papers and technical papers for inclusion in the CABA Research Library. These contributions help continue to grow the world's largest collection of "connected homes and intelligent buildings" research and information.
- 3. The Council will comprise people who are active in the intelligent building and/or connected home sector(s).
- 4. CIC members will have the opportunity to provide reviews using the evaluation template ("Reviewer Checklist") provided on the CIC web page. Each review submitted will be worth twenty-five (25) "CABA Bucks". The CIC members can utilize "CABA Bucks" to purchase CABA research, memberships, CABA event registrations, etc. As a general principle, CIC members can select, from a master list of documents, a maximum of two (2) papers. New reports may be requested once the reviews are completed.
- 5. Reviews are to be submitted to the CABA office. If the reviewer has approved the document, it will be posted to the CABA Research Library. If the review for a given report remains outstanding after (3) months, that report will be made available to other CIC members to select and review. Once a paper has been approved or rejected, it will be removed from the master list of documents requiring reviews.
- 6. All CIC members are encouraged to submit reports they find on their own, they do not need to select reports form the master list. These reports must have a publication date within the past twelve (12) months and not already be in the CABA Research Library.

- 7. CIC members must commit to reviewing five (5) reports annually. Shoud they miss this requirement, they will be given six (6) additional months to do so. If the five (5) reviews have still not been completed at that point, they may be removed from the CIC. In addition, the reviewer's name will be removed from the posted list of CIC members.
- 8. Research reports, case studies, white papers and technical papers can be submitted by anyone in the industry for review, including CIC members.
- 9. The Council members will select a Chairman and Vice-Chairman for a period of two (2) years, which can be renewed.
- 10. The CIC will be involved in providing feedback and input on the CABA Information and Knowledge Center.
- 11. The Council will receive support from the CABA Secretariat, in particular from CABA's Senior Director, Research Operations.
- 12. There will be a minimum of two (2) meetings annually via either Teams or Zoom, unless otherwise called by the CIC Chairman.
