**Description**: On October 20, 2022, the White House announced a plan to create a cybersecurity assurance mark for consumerconnected products. The effort is well underway thanks to significant work from NIST and the private sector, led by groups including the Consumer Technology Association. Mike Bergman, Vice President at CTA, provided real-time updates on this fastmoving activity as the U.S. government and private sector work together to establish an effective program at a national scale.
